At JFK Library, Biden posits 'end of cancer as we know it'

With Dorchester Bay behind him, President Biden on Monday outlined plans to "end cancer as we know it," pitching the possibility of a vaccine instead of "grueling chemo" treatments.

The city and state's political class sat in front of him at the JFK Presidential Library and Museum, which Biden called a "powerful place for reflection and remembrance." The White House picked the library as the setting for his "Cancer Moonshot" speech, keying off on the sixtieth anniversary of President

Kennedy's call to action, delivered at Rice

University in Texas, for the US to go toe to toe with the Soviet Union in the race to dominate space and reach Earth's celestial satellite first.

Biden namechecked US Sen. Ted Kennedy, who died from brain cancer in 2009, and his son Beau Biden, who died from the same type in 2015 at the age of 46. Biden also noted that his labor secretary, Dorchester's Marty Walsh, is a survivor of childhood cancer.

The US faces an "inflection point" similar to Kennedy's call for unification in 1962, Biden said, pointing to cancer's lack of discrimination against one's politics. "It doesn't care if you're a Republican or a Democrat. Beating

Boston Home resident finds hope in painting

Life didn't seem worth living for Beth Fournier after a devastating illness that left her paralyzed, blind, and using a wheelchair before the age of 30. Candidly, she said, she wanted to die.

Then, after she settled in at the Boston Home on Dorchester Avenue, she picked up a paint brush and found a piece of freedom and hope through watercolor painting.

Now 33, Fournier will have two watercolor pieces

on display at the Boston Home's annual art show in the Mary Jo Montani Gallery on the campus this week (Thurs., Sept. 15, from 6 p.m. to 8 p.m). The event represents a life-turning experience on a journey that Fournier told the *Reporter* in an interview was about keeping at living after she was struck seven years ago by a disease that attacked her central nervous system and quickly put her in a lengthy coma. And that was just the beginning of her travails.

"I really didn't want to be alive," said Fournier about the lowest times during her illness. "I didn't know anything, and I couldn't even see anything. It was very hard for me at first because I was very angry about being at the Boston Home. I was not (Continued on page 20)

New law sets up funding for Dot's shoreline and parks

Some of Dorchester's shoreline is expected to receive a boost amid the ongoing development boom with the establishment of a trust geared toward funding preservation and climate mitigation costs.

Gov. Baker this summer signed a law that establishes a trust meant to ensure the "long-term conservation, maintenance and improvement" of properties along the shoreline.

The law places the governor's chief of energy and environmental affairs as the administrator of the fund which is expected to receive income from a variety of

sources, including developments planned for the Morrissey Boulevard corridor, according to state Sen. Nick Collins and state Rep. Dan Hunt, who shuttled the legislation to the governor's desk.

The fund could also attract money from public or other private sources, such as federal or private grants, and donations. Lawmakers are eyeing legislative appropriations and long-term commitments, not just one-time infusions, to boost the fund.

"We want to make sure the environmental investments stay locally and we can also find ways here to support an increase in maintenance," Collins told the *Reporter*.

The trust is specifically meant to benefit the beaches at Tenean, Savin Hill, and Malibu Beach, the shoreline along Columbia Point, and Victory Park within the Morrissey Boulevard corridor. McCormack Memorial Park, a small patch of parkland located on Columbia Road, is also included on the list,

Taking a measure of how the primaries played out

It was the weekend before primary election day, and one of the Democratic candidates for Suffolk County district attorney, City Councillor Ricardo Arroyo, was caught in a rip tide of retracted endorsements. For voters already tipped off by damaging news reports about alleged

sexual misconduct in his teen years, the impression was only reinforced when the faces of erstwhile supporters backflowed in a final gush of campaign mail. Arroyo's defectors were legion, including two US senators, a Congresswoman, and Boston Mayor Michelle Wu. But one of his

colleagues, Roxbury's District 7 Councillor Tania Fernandes Anderson, held her ground. She told her followers on Twitter that the "choice was clear," and that she was still with Arroyo.

"Do we want to move ahead with progressive and forward-thinking criminal justice policies," she asked them, "or do

A stabbing at the Burke; man dies after hit by car

A student was stabbed — allegedly by another student—inside Jeremiah E. Burke High School on Monday morning, according to Boston Police. The victim's wounds were reportedly non-life-threatening. As part of their investigation, police on Tuesday arrested a 17-year-old Randolph teen in connection with the case.

A 91-year-old Dorchester man was fatally injured last Thursday (Sept. 8) when he was struck by a car at the intersection of Morton Street and Selden Street in Dorchester just after 9:30 a.m. The victim was rushed to Beth Israel Hospital, where he was initially listed in critical condition. The driver of the BMW who hit the pedestrian stayed on the scene and was interviewed by State Police, who say the victim was in the crosswalk when he was hit. "The investigation into the crash is ongoing to determine whether criminal charges are warranted," State Police said. The victim later died from his injuries, according to state Rep. Russell Holmes.

A woman was arrested inside Ashmont Station last Thursday after she allegedly assaulted two people during a dispute involving use of the station's restroom. Transit Police officers said they observed the suspect—Tasheaka Buchanan, 27, strike a man and woman whom she confronted. Arresting officers say Buchanan "exhibited signs of intoxication" and found that she was wanted for arrest on outstanding warrants for assaults and other charges out of Dorchester, Roxbury, and South Boston courts.

A 27-year-old Dorchester man was arrested last Thursday by a team of law enforcement officers, including the FBI Gang Task Force and Boston Police Drug Control Unit. Tristan Preval has been charged with illegal gun possession and drug dealing. During a search warrant, police say they recovered a 9mm Glock with a high-capacity feeding device, "two plastic bags of a white powdery substance believed to be cocaine, and two plastic bags of a rock like substance believed to be crack cocaine."

Development firm buys CVS property in Lower Mills; 'No plans for the moment'

A well-known mixeduse development company purchased the CVS property on Dorchester Avenue in Lower Mills for \$9.5 million in mid-August, but officials at the firm said that while it is a key piece of real estate, they don't have any immediate plans to change things.

Crosspoint Associates, which is based in Newton, recently developed the Newton Nexus that hosts a Stop & Shop Express and the Boston Ballet School. They also have a portfolio in South Boston's Fort Point Channel that includes a Trader Joe's store.

Jonathan Hueber, managing principal at Crosspoint, said that the CVS site is "a great piece of real estate at the end of the day. We love Dorchester, and we love the Lower Mills neighborhood in particular. We don't have any plans for the moment. We hope to evaluate that over the next few years, but

immediately there are no new plans and there's a long-term lease in place."

He said his firm has had a long relationship with CVS stores and has included them as tenants in several of their developments around New England. He described the Lower Mills purchase as a "covered land play," a development strategy whereby a developer buys an income-producing property with the intention of redeveloping it to a higher and better use at some point.

"We love to be good stewards of our real estate and listen to the community and speak to the community," Hueber he said. "Down the line hopefully we do have some other project there."

According to city assessing records, the property is listed at 65,873 square feet and contains only the CVS building. An adjoining parking lot is controlled by the Archdiocese of Boston.

Fluker Oakley: 'Water park' to stay at Ryan Playground

There is no truth to rumors that a popular spray deck water feature at Ryan Playground on River Street will be closed permanently, according to state Rep. Brandy Fluker Oakley.

"I'm going to kill the rumor," she said during Monday's Greater Mattapan Neighborhood Council (GMNC) meeting. "We've been inquiring about the wading pool since mid-July when this was brought to our attention and the DCR finally got back to us. It is not closing permanently. That rumor is not true, but it is true they are considering renovations to the water

park, parking area and the playground itself."

Fluker Oakley said the DCR has committed to a robust round of community meetings for any renovation proposals they come up with while saying for certain that the spray deck and wading pool are not closing permanently and that

any renovation work will not be done in the summer during high-use times.

The DCR did not return several inquiries over the last month from the *Reporter* asking for clarity on the matter.

Neighbors, Boston Bowl await call on billboard conversion

A group of neighbors and the owners of the Boston Bowl property on Morrissey Boulevard are in "wait and see" mode this month as an Administrative Law Judge (ALJ) reviews an appeal to convert an existing static sign on the site into a digital billboard that faces the Southeast Expressway.

The state's Office of Outdoor Advertising (OOA) discussed the matter during its monthly virtual meeting last Thursday and noted that they, too, are awaiting the judge's decision.

The OOA denied the conversion last January, citing a technical issue. But that decision was appealed in February by the proponents from Bay Colony Associates LLC, which is controlled by Philip Strazzula III and Joseph Sammartino Jr. The billboard is rooted in the parking lot of Boston Bowl, which they also own. Two hearings on the appeal were held in May.

The applicants were denied, said John Romano of the OOA, "due to a spacing issue with another billboard at 65 Tenean Street." However, he added, before the January denial, Bay Colony had worked out an agreement with the

company whereby they would take down the billboard on Tenean Street to eliminate the technical violation. "That was submitted to the judge," Romano said.

In the meantime, opponents of the conversion, including Port Norfolk activist Maria Lyons and other Dorchester civic leaders, petitioned the ALJ for an "intervenor"

Clear Channel billboard to work on the case. An "intervenor" is a party that does not have a substantial and direct interest but has clearly ascertainable interests and perspectives essential to a judicial determination. A hearing on whether to grant them that position was held in late August.

"The Boston residents' group has petitioned to intervene. We're sitting tight to see what like Port Norfolk, Cethe judge rules and determine how we go forward," said Romano... Nothing is final until the hearing officer at ALJ rules.'

It was noted by those in opposition that Mayor Michelle Wu and Councillor Frank Baker oppose the conversion, as did former Mayor Kim Janey. Also opposed are civic associations

dar Grove, Clam Point, Columbia/Savin Hill, and the Dorchester Waterfront coalition. The Neponset River Watershed Association also "strongly opposes" the proposal, noting the billboard's proximity to the Neponset Greenway.

The Pope's Hill Civic Association does not oppose the billboard conversion, according to

statements made during the OOA meeting.

Bay Colony attorney Kelly Frey said that her clients are "hopeful the ALJ will find it appropriate to allow the conversion," he said. "We have committed to removing seven existing billboards in the surrounding neighborhood. This board already exists and would be only converted to digital format."

Frey did not return an email from the Reporter seeking to clarify the location of the seven billboards she said are proposed for removal.

Lyons said there are more problems with this board than just a spacing issue. "We believe there are many violations there and we would like to have it publicized that all these other officials and associations are opposed to this billboard there," she said.

Romano said he was not sure if the matter would come back before the board. "I can't promise another hearing and I'm not making any commitments or promises there will be another hearing at my level. We'll all just wait to see what the judge says," he concluded, while noting there is no timeline for his decision to be issued.

City touts heating system replacements for seniors, citing onset of winter months

As another cold New England winter approaches, city officials are urging seniors to take up an opportunity to replace their heating systems while the weather's still warm.

Richard O'Brien, deputy director of the city's Boston Home Center and a Dorchester resident, said the "Seniors Save" program helps income-eligible seniors replace heating systems that are failing and inefficient. The program, backed by federal and city funds, offers an \$8,000 grant, and, if needed, a zero-interest deferred loan for the remaining balance.

To qualify, applicants must be Boston residents, 60 years or older, and living in an owner-occupied home or condo. The heating system targeted for repair must be at least 12 years old, and the applicant must

80 percent of the Boston area median income.

The program also helps seniors pick out a contractor for the work.

A four-page application is available on the city's website, boston. gov/departments/housing/boston-home-center. People can also call 617-635-HOME for more details, particularly about whether they're income eligible. O'Brien said seniors, once they're no longer earning active income aside from Social Security or a small pension, often can meet the low to moderate income guidelines. "We ask that they call and at least check," he said.

The "Seniors Save" program was set up after the extreme winter weather that hit the region in 2015 and 2018. O'Brien's team handles the 311 calls for senior home repairs in the city, and while typically it would receive one or two heat-related calls during a cold winter week, the extreme weather that caused temperatures to stay down for days and weeks led to a "cascading failure across the city, which is very hard to address." His team saw radiators cracking due to the ice built up inside.

But it's all preventable, he said. Replacing a heating system under extreme weather conditions is dangerous and expensive, and leaves the house vulnerable to the cold. Doing it before the winter months is cheaper, and only takes a few days.

"When you can do that prior to the active heating season, it's so much easier," he said "That's why we're asking people

have an income up to if they're interested in the program to apply now.

"Seniors Save" allows oil-to-gas conversions. If a home has been placed in a trust, the "Seniors Save" team is still willing to have a conversation with the owner(s) about how they can help.

The program was initially geared to handle 50 residential units per year. But over the last two years, they've exceeded 100 units per year, and they're on track to do so again this year. It has in total helped fix heating systems in 350 units, many of them in Dorchester and Mattapan, according to O'Brien.

Beyond the heating system replacement program, the Boston Home Center, which is within the Mayor's Office of Housing, also offers minor and moderate repair programs. For minor repairs, the agency contracts with four nonprofits who have handymen available to deal with things like a leaky faucet, a torn window screen, or the installation of grab bars in the bathroom, making it easier for a senior to stay in their home.

The moderate repair program focuses on leaking roofs, structurally unsound porches, and interior plumbing leaks.

O'Brien said the "Senior Saves" program focused on the heating system often leads to additional repairs, since its workers notice buckets under the roof or stairs that are coming apart. "We made the terms as favorable as possible so the work can be done before it becomes an emergency," he said.



Taking a measure of how the primaries played out

we want to retreat to a stale status quo that will continue to victimize the least powerful among us?" In a primary dominated by candidates trying to boost name recognition, some of which had been cultivated over years, the DA's race in Suffolk County stood apart. The current appointed DA, Kevin Hayden, a figure of low profile before this year, came out on top with 48 percent of the vote, while Arroyo, a second-term councillor from Hyde Park, got 41.6 percent. What also stood out in the race was the abnormally high share of blank votes – 10.5 percent – which some observers decoded as a triumph of conflicted feelings over purpose-driven choice. A month before the vote, both candidates were being presented to voters through successive volleys of negative news reports. But if the race was between different shades of ethical clouds, it also was being defined by different camps with different views of criminal justice and police oversight.

First, it was Hayden on the defensive, denying that he tried to quash an alleged coverup by Transit Police officers that sprang from a traffic dispute. The coverup charge would re-emerge less than a week after the election, when the *Boston Herald* reported that the previous DA, now the US Attorney for Massachusetts, Rachael Rollins, had been allowed to recuse herself and her office from a federal investigation of Hayden and his first assistant DA.

In the next volley of reports, The Boston Globe revealed sexual assault allegations against Arroyo dating from 2005, when he was in high school. The allegations did not lead to criminal charges, but Arroyo gave conflicting indications about whether he was aware of having been investigated, which, in turn, prompted questions about his fitness to practice law. The Arroyo camp blamed the revelations on improper leaks, pointing fingers at Hayden and police. Hayden denied any role in release of the information. And, after one of Arroyo's alleged victims reaffirmed her story in the week before the primary, Hayden made it clear that unprosecuted didn't necessarily mean unfounded. On Aug. 24, the day after *The Boston Globe* ran its first story about allegations against Arroyo, two police organizations—the Boston Police Patrolmen's Association and the Boston Police Superior Officers Federation--called for him to drop his campaign for DA and resign from the City Council. At the same time, police were increasing their individual donations to Hayden's campaign, with \$7,825 in August alone from 29 police force employees, mostly uniformed.

One of the largest donors, contributing \$1,000—the maximum allowed in Massachusetts—was Juan Seoane, identified on Hayden's campaign finance report for August as "Law Enforcement City of Boston."

In 2017, the CEO of Tara Construction Inc., Pedro Pirez, asked Seoane to look up information about the identity of Jose Martin Paz Flores, an employee who had recently been injured on the job. According to WBUR, Seoane shared his findings with the Boston Police Department's liaison to US Immigration and Customs Enforcement (ICE). Paz Flores was then arrested by ICE for being in the country illegally—right after a meeting with his employer.

The US Labor Dept. responded by suing Tara Construction and Pirez. In June of this year, a jury in federal court awarded \$650,000 in damages for unlawful retaliation against an injured worker. Hayden's more prominent backers also included champions of police reform like state Sens. William Brownsberger and Lydia Edwards. For his part, Arroyo had pushed for reforms with more emphasis on racial equity since his election to the Council in 2019. Along with supporting a shift of funds from law enforcement to other agencies, he raised questions about police cooperation with ICE, especially in connection with potential exposure to deportation from the gang database shared between Boston Police and other agencies. During the summer, he also criticized the alleged Transit Police coverup and the Boston Police response to a demonstration in in the city by the white supremacist group Patriot Front. By the end of August, after sexual assault allegations had been amplified in a follow-up Globe story, City Council President Ed Flynn suspended Arroyo from leadership of two committees, one of them set to draw new council districts. Two days later, divisions intensified by the DA's race broke out in a chaotic meeting of the Council, extending to a melee between opposing groups outside the Iannella Chamber. Among councillors themselves, there was a sharp denunciation of Arroyo by District 3's Frank Baker and an appeal by Fernandes Anderson for equity and respect that was spiked with expletives. Two days after the meeting, Fernandes Anderson expressed regret for use of the expletives, but made no apology for speaking out about "violent and veiled racism." Reacting to the turmoil, political analyst and former councillor Lawrence DiCara said, "This was very unfortunate for the body and the individuals

involved. I'm troubled by the vitriol, the language, the ad hominem attacks."

But the policy director at Progressive Massachusetts, Jonathan Cohn, said Fernandes Anderson was doing a district councilor's job: asserting the power of a voting bloc and protecting its interests. He said the same mission applied to voters supporting Arroyo in areas such as Roxbury, Grove Hall, and Mattapan, as well as support from other blocs in other parts of the city for Hayden. Arroyo did carry the vote in Roxbury's precincts, as well as in adjacent parts of Dorchester and Mattapan, most of that in Wards 12 and 14. But the two wards still gave Hayden more than 40 percent of the vote, with a percentage of blanks below the city average.

Unsurprisingly, Hayden did very well in Ward 16, Precinct 12, a perennial high-turnout area in Dorchester near Neponset Circle. Home to many current and former police officers and firefighters, the precinct gave him 87 percent of the vote, with few blanks. For all of Ward 16, including the rest of the Neponset area, Hayden received almost 65 percent of the vote, slightly below the 69.4 percent from the Ward 20 precincts in West Roxbury and slightly above the percentage in South Boston. In Dorchester's Ward 17 (Codman Square-Lower Mills), Arroyo managed a slight lead, but Hayden picked up almost 63 percent of the tally from the vote-rich Ward 13, Precinct 10, in Dorchester's Columbia-Savin Hill area. In Ward 18, Arroyo carried precincts in Roslindale and Mattapan, while Hayden's strongest showing was in the Fairmount section of Hyde Park and Readville.

As first reported by GBH News, the citywide total of blanks was greater than Hayden's advantage not only in Boston, but also in many precincts. And the percentage of blanks was greater than in other high-profile contests, including the uncompetitive Democratic primary for governor.

In the progressive stronghold of Ward 19, covering most of Jamaica Plain and Roslindale, Hayden got less than one-third of the vote, but a potentially hefty advantage for Arroyo fell short of 51 percent, thanks to a share of blank votes at more than 12 percent.

In response to a pre-election touting of Arroyo as a DA who would "challenge the systems that oppress us," an unpersuaded voter in East Boston's Ward 1 tweeted, "I am not voting for DA tomorrow but (in my opinion) this comment and everything I've been seeing around this race tells me that Boston politics really are losing all touch with reality." Despite the neighborhood's large Latino population, Hayden got 49 percent of the

ward's vote, with just under 40 percent for Arroyo and slightly more than 10 percent in blanks. The percentage of blanks for DA also ran above the citywide average in other higher-end progressive pockets, in the South End, Jamaica Plain, Back Bay, and the South Boston side of Fort Point Channel. DiCara says those voters might have been swayed by Arroyo's last-minute loss of high-profile endorsements from progressive stalwarts such as Mayor Wu.

"I think a whole bunch of people who were going to vote for Arroyo went by the mayor," he said, "and couldn't bring themselves to vote for Hayden." Cohn argued that, instead of exerting power as a bloc, some progressives cast their vote to express feelings about candidates. "It's an understanding of voting," he said, "as an individual, rather than a communal act." And, as one long-time advocate reminded her followers on Twitter, "Those who understand power vote for their candidate period."

Aside from the DA's race, the Democratic primaries in Boston had less drama and less crackle of insurgency than the last "mid-term" contests in 2018. Headlining the earlier election were successful challenges to the political mainstream by Ayanna Pressley and Rachael Rollins, but there were also upsets over members of the Democratic leadership team in the state's House of Representatives by Nika Elugardo and Jon Santiago. The ferment pushed Boston's voter turnout to almost 25 percent, the highest figure since 2006, but the figure for this year's primary dropped to 19 percent. Cohn agreed that 2022 was no match for 2018's "synchronicity of messaging," amplified at pre-pandemic forums that, short of changing minds, could get traction with voters on social media.

"It didn't have that linear advance that would lead to a lot more campaigning," he said. "You didn't have the same number of in-person events. There were more virtual events—and fewer events at all." The most notable advances by Democratic women in 2022 were Maura Healey's nomination for governor – without active opposition – and the nomination of former Boston City Councillor Andrea Campbell for attorney general. In Boston, one year after a strong run for mayor, Campbell got 68.7 percent of the vote, despite endorsements of her opponent, Shannon Liss-Riordan, by Wu, former acting mayor Kim Janey, and US Sen. Warren. Though Campbell failed to advance into last year's final election, Cohn said her candidacy, buoyed by an endorsement from The Boston Globe, left voters with "generally positive feelings. They loved her," he said, "or they didn't dislike her." After Sonia Chang-Diaz left her state senate seat open to start a campaign for governor that she later suspended, five Democrats aimed to succeed her in the 2nd Suffolk District, mainly comprising Roxbury and parts of Jamaica Plain, Mission Hill, Mattapan, Hyde Park, and a small area of Dorchester. The top vote-getters were both incumbent state representatives -the winner, Liz Miranda, with 31.4 percent, and Nika Elugardo, with 25.9 percent. The three other candidates included one of the district's former senators, Dianne Wilkerson. Elugardo dominated the vote around her House district in Mission Hill and Jamaica Plain. But Miranda dominated in Roxbury precincts, as well as in parts of Dorchester and Mattapan in Ward 14. She even got more than double the votes for Elugardo from Ward 18 precincts in Hyde Park and Mattapan. "Liz has been in community and her professional roles have taken her across the district for the last 25 years," said Will MacMillan, a junior researcher for Rivera Consulting Inc. a strategy group for the Miranda campaign. "And she put a real emphasis, and we put a real emphasis in our path to victory in terms of how we were prioritizing our mail and digital and person-to-person outreach resources, trying to earn votes in every neighborhood, and not just playing a single geographic base.' As a result, Miranda picked up almost one-quarter of the vote in Elugardo's stronghold in Wards 10 and 19. MacMillan said the campaign also made sure to alert and engage voters in parts of Hyde Park and Mattapan recently added because of the district's new boundaries.

"One of the big reasons that Liz got the result that she did," said MacMillan, "is that in a low turnout, multi-candidate race, it really comes down to who has identified the most supporters and who has the operation to make sure they turn out." Said City Councillor At-Large Ruthzee Louijeune, one of Miranda's supporters: "The result of the 2nd Suffolk Senate race was a product of two decades of deep community work that Senator-elect Liz Miranda has put in. Liz's campaign centered the voices of people typically left at the margin, young people, immigrant communities, formerly incarcerated folks, jaded voters, etc. It was led with a sense of love and intentionality that very clearly resonated with the people of the 2nd Suffolk and got folks excited about getting civically engaged."

YESTERYEAR ARCHIVE

Dorchester Historical Society Nathaniel and Mary Fenno Tucker

The following has been excerpted from the Dorchester Historical Society's house history project.

Born in Canton (later Stoughton) in 1805, Nathaniel Tucker was the eldest of James and Betsey (Withington) Tucker's eight children. Little is known of his early life, but the one record we do have is of his marriage to Mary Fenno in 1829. Nathaniel and Mary had two daughters: Mary Eliza, who married Timothy Munroe Rhodes, and Frances Louisa, who married Allen Darrow Smith. The photo of Mary Tucker must have been taken in the 1860s, when her husband's career would have been at its peak.

Nathaniel was a leather merchant, with offices on Pearl Street in Boston. He



dealt in boots and shoes on a wholesale basis, and the company was known as Nathaniel Tucker & Co.

Tucker's business appears to have been very profitable. In December 1872, he applied for a passport, planning to travel to Europe with his wife and daughter for a period of two years. In preparation for this trip, Timothy Rhodes, then deeply involved in real estate, advertised the Tucker house at 19 Sumner Street to let, providing rare detail about the house and other buildings on the estate. It was listed as having "all the modern improvements."

At that time, "modern improvements" might include central heating with a coalfired furnace and hot air through natural convection and gas lights. Through this advertisement, we know that the property contained a stable, with a bowling alley and billiard room connected. The large garden, "with fruit and vegetables in abundance" is a reminder that Dorchester still

embodied its agrarian origins.

When the family returned from Europe, they moved from 19 Sumner Street to Train Street, near Neponset Avenue. Tragically, on November 6, 1875, daughter Mary was riding in her carriage with her grandchild when she was thrown from the carriage and killed instantly. Nathaniel Tucker died 11 years later, in 1886.

Updating community efforts to keep St. Brendan's open

It has been a few months since Cardinal Sean O'Malley issued at least a temporary reprieve for St. Brendan's Church on Gallivan Boulevard. The church's pastor had recommended that it be "relegated"— a canon law term for closing it— due to a litany of issues ranging from deferred maintenance to low attendance and poor receipts at the offertory box.

Instead, back in May, O'Malley called for a "working group" of parishioners and Archdiocese officials to huddle up and come up with a "financial plan" to keep the church building open.

The working group is supposed to issue its recommendations to O'Malley by Sept. 30, but sources close to their work say they will likely need more time, since the committee- made up of a dozen parishioners and St. Brendan School parents—did not start meeting until July.

But, to hear one key member, longtime parish and civic activist John O'Toole, tell it, the group is making tangible progress toward a viable plan to keep the church open as part of St. Martin de Porres parish, which also includes worship space at St. Ann Church on Neponset Avenue.

"You may be surprised to know there is reason to be hopeful for the future of St. Brendan's," O'Toole wrote in a memo shared with the Reporter this week, that frames their ongoing discussions as an "encouraging, collaborative effort."

According to O'Toole, the group has begun the process of seeking Community Preservation funding through the city of Boston, for which it is eligible, like many other worship spaces in Boston, for taxpayer-funded grants to help pay for maintenance fixes. But the group is adamant that the costs associated with fixing the church building have been inflated by the archdiocese in years past. For example, they believe that the roof of the church can be repaired by tradespeople from the parish, without the much larger expense of a full replacement.

It'll take far more than patches to the roof to make St. Brendan Church a sustainable worship space for the flock that still goes there. On Sunday, about 200 people attended a special Mass on the 21st anniversary of the Sept. 11 attacks with a special focus on the first responders who represent a big chunk of the parish community. A flag-raising ceremony held in the adjacent schoolyard after the Mass was well attended as well, O'Toole notes.

The school is an asset of the parish that everyone seems to agree is a huge plus for the community. Enrollment there is up, the school itself is "in the black" — and there's even a waiting list for the youngest grades. And, as O'Toole notes, "It is a pipeline for children to be involved members of the faith community." The committee is pushing for a re-boot for a parish youth group to get younger families more invested over the long haul.

There will need to be a robust fundraising plan to help underwrite all of this. The archdiocese can help by making better use of the church's lower hall as a venue for events.

There's no doubt that there's a growing will to "save" St. Brendan's. The question that all interested parties need to resolve this year is "the way." Bill Forry

Let's meet Mattapan residents where they are when discussing bike lanes

It isn't a shock that communities like Dorchester and Mattapan continue to be one of the last communities to receive bike-related amenities. As a person who lives in Mattapan and a person who works for an organization (Mattapan Food & Fitness Coalition, or MFFC) that focuses on biking as one way to get resident's bodies moving, there are common issues that come up:

1. The bike lanes are for whom? Black people do not bike!

2. The bike lanes will cause gentrification. My rent will skyrocket!

To be honest, the residents who think this way are not wrong. This is their experience and those who are advocating for bicycling must honor that.

It's hard for me to think about advocating for more bike lanes if the residents I serve need basic resources such as housing, food, water, and clothing. Until we resolve these issues around housing, there will continue to be resistance to bike lanes and it will continue

to be seen as a negative thing.

This is the time for the City of Boston to do some real relationship building with the communities that weren't in the bike announcement. This is the time for the City of Boston to intentionally include residents in the planning.

MFFC has already established trust in Mattapan and has engaged them on various transportation projects. Our focus is to bring information and introduce residents to decision makers and those who have the information. When it comes to biking, we focus on the health benefits it could bring, NOT on convincing them that bike lanes are the way to go.

When it comes to transportationin general, we talk about the root issues and bring speakers that can relate to the audience. We have done this through our Transportation Talks (in partnership with the Powerful Pathways organization), which have engaged more than 700 unique individuals over two years. MFFC and Powerful Pathways have plans to continue these conversations in the coming year.

Each community of Boston is in different stages when it comes to biking and the residents there need to be met where they are.

Dot's Ward 17 regularly serves up elected officials with lots of clout

Is there something in the water in Ward 17, perhaps the Neponset River that flows by it? The district, which includes Lower Mills, and parts of Codman Square and Mattapan, has been home to mayors (2), attorney generals (3),

and a speaker of the Massachusetts House, among other elected officials.

Mayor John B. Hynes, who served through the 1950s, lived on Druid Street off Gallivan Blvd. When the city's legendary fourterm mayor, James Michael Curley (he was also governor in the mid-1930s and served four terms as a congressman) returned to the mayor's office from his second stay in prison, this time for mail fraud, he said, "I have accomplished more in one day than has been done in the five months of my absence."

He was referring to City Clerk Hynes, who had served as acting mayor while Curley was away. In 1949, Hynes, who took Curley's public comment as an insult, ran for mayor against him and beat him, beginning his decade-long service as mayor. Francis Sweepstake" Kelly was the state's 53rd lieutenant governor (1937and the state's attorney general from 1949 to 1953. He got his nickname "Sweepstakes" sponsoring legislation for a state lottery. Kelly's home was on Morton Street, at the corner of Pleasant Hill Ave.

Edward J. McCormack Jr. also made his home on Morton Street, moving to Dorchester from South Boston in the middle of his political career. He was the namesake son of Southie's colorful "Knocko" McCormack and the nephew of US House Speaker John W. Mc-Cormack. He served as attorney general from 1959 to 1963.

In 1962, he ran for the Senate seat John F. Kennedy had vacated when he was elected president. With interim Sen. Benjamin Smith opting against running for a full term in 1962. Ted Kennedy, who would turn 30 that fall, entered the race against McCormack. Some campaign staffers

circulated a pair of bumper stickers which read "I Back Jack." and "But Teddy isn't ready"

During a famous debate a South Boston High School, McCormack said, "The office of US Senator should be merited, not inherited," adding that if his opponent's name "was Edward Moore," not Edward Moore Kennedy, "your candidacy would be a joke." But he lost as Ted's last name was Kennedy.

In 1974, McCormack wrote a busing plan for desegregation in Boston with much less busing than other possible plans. But US Judge W. Arthur Garrity instead chose a plan with much more busing. And we all know of the divisions, heartaches, and racial violence that accompanied desegregation with busing.

Lower Mills native Joe Timilty

made his home on Maryknoll Street during his terms as city councillor, state senator, and chair of the US Commission for Neighborhoods to which he was appointed by President Jimmy Carter. He narrowly lost contested races for mayor to incumbent Kevin White in 1975 and 1979.

Brian Donnelly, Tom Finneran (mentioned below), and future Mayor Thomas Menino were part of Timilty's political organization during those years. Donnelly, of Clearwater Drive, was a state representative 1973-1978 and, from 1979 to 1993, a member of Congress where he was campaign manager in electing Tom Foley as US House Speaker. In 1993, President Clinton named him US ambassador to Trinidad and Tobago. When he came back to the state, he mounted an unsuccessful bid for governor.

Other Ward 17 notables:

• Tom Finneran of Countryside Drive was Massachusetts House Speaker from 1996-2004 and before that was House Ways and Means chair.

• Former State Senator Linda Dorcena Forry, wife of Reporter editor Bill Forry and daughterin-law of Reporter co-founders Ed and Mary Casey Forry, lives on Richmond Street;

• Though long a resident of Savin Hill's Ward 13, with his move to Butler Street in Lower Mills, Martin "Marty" Walsh, now lives in Ward 17. He was a state representative before he was being elected mayor of Boston (2014-2021), and is now US Secretary of Labor.

• Andrea Campbell of Groveland Street was a city councillor, mayoral candidate, and today is the Democratic nominee for attorney general. She is heavily favored to be elected to that office in November.

Someone from Wards 13, 14, 16 in Dorchester should tell their stories like this too!!

Lew Finfer is a Dorchester resident. He received one write-in vote for Congress in the recent election and he didn't vote for himself!



New law sets up funding for Dot's shoreline, parks

(Continued from page 1) which mostly consists of state Department of Conservation and Recreation properties.

The fund comes as major developments are set to rise along the shoreline. The largest, known as Dorchester Bay City, is currently under review by city planners. Expected to cost \$5 billion over 15 to 20 years and span 6.5 million square feet, the project will also have 21 acres of open space on the 36-acre site, much of it on the shoreline between Moakley Park and the Harbor Point apartments. The project will essentially create a new waterfront neighborhood, steps from the JFK/UMass MBTA Station.

"It's a receiver and a steward of the work that needs to be done," Collins said of the Dorchester Shores trust legislation, which is modeled on a 2008 law creating the

Gintautas Dumcius photo Salisbury Beach Preservation Trust Fund. People using that site, which is on the Massachusetts-New Hampshire border, for camping and parking are charged \$3 admission. The money collected has been spent on rehabbing the boardwalk, improvement to comfort stations, installation of fencing, beach and campground sewer fixes, and routine expenses.

A similar trust exists for the maintenance and preservation of Horseneck Beach, which is in Westport, close to the Massachusetts-Rhode Island border.

"As discussions move forward about environmental mitigation at the state and city level, this ensures tDorchester] is a place and focused area for us to invest in infrastructure that we know we badly need," Collins said.

Sea level rise is expected over time to hit Dorchester with significant flooding from storm surges, with the areas close to JFK/UMass Station expected to be particularly vulnerable, according to a city report titled "Climate Ready: Dorchester" that says "damage to exposed roads and the MBTA Red Line from this type of storm could isolate Columbia Point from the rest of Dorchester and impact transportation connections to North Quincy." The study added that "Flooding will extend by mid-century along the Neponset River and Columbia Point."

Moakley Park, which is shared by Dorchester and South Boston, is expected to become a "flood entrance" for the South End, South Boston, and parts of Roxbury, the report continued. The park recently received \$2.2 million for climate change mitigation.

McConnell Park, a 6.2-acre site by Savin Hill and Malibu Beach, recently saw \$7.1 million in improvements,

including artificial ridges to protect the park's softball and soccer fields and neighborhood residents from flooding.

The Dorchester Shores trust will create a funding source to tie together resiliency and maintenance of a "vibrant" green space, according to Alice Brown, chief of planning and policy at Boston Harbor Now, an advocacy group.

"It's a great contribution to getting toward the goals we want," she said.

Around the same time he okayed the establishment of the Dorchester Shores trust, Baker also signed a bill creating a special commission to study the Morrissey corridor, with a focus on what it needs to improve its transportation, climate resiliency and infrastructure needs. The commission has a June 2023 deadline to file its report with state lawmakers.


A large crowd came out to see the cars and grab a ride on the horsedrawn wagon – and the rain didn't seem to hold anyone back.

Boston to challenge US Census count of city's population

City Hall plans to challenge the US Census Bureau's population count for Boston, saying the federal effort missed college students and the foreign-born population, as well as people inside correctional facilities.

Mayor Michelle Wu said city officials also object to federal racial and ethnic classification changes for the 2020 census, which took place during the pandemic. An accurate count helps determine federal funding for city programs.

accurate census count across every neighborhood and community," Wu said in a statement. "This count is the foundation to assess the needs of all of our communities, ensuring that Boston receives crucial federal resources, and it should reflect our full numbers."

The Census says Boston's population grew 9.4 percent between 2010 and 2020. The 2020 total was 675,647, with the city adding Hispanic and Asian residents. The non-Hispanic Black/

"Boston deserves an African American population fell 6.4 percent.

> In October 2021, acting Mayor Kim Janey said the city planned to formally challenge the count. Allston-Brighton City Councillor Liz Breadon also raised alarm about the Census estimate showing a 5.9 percent loss in Allston's total population, and a 40 percent decline in people living in groups, noting that the pandemic led to colleges and universities sending students away.

Councillor At-Large Ruthzee Louijeune said her office previously met

with the Wu administration to press for the challenge.

"An accurate count of Boston residents will ensure that all our communities, especially our Black & Brown communities that have suffered from decades of disinvestment, get the resources and attention needed to thrive," she said. "Additionally, the US Census Bureau must respect how people identify themselves racially and ethnically. The Census must consider simplifying categorizations, particularly for

Latino, Brazilian, Middle Eastern, and North African respondents, to correctly capture our demographics.'

Census tracts with foreign-born residents had lower response rates, city officials said, suggesting that language barriers and government mistrust, driven by the anti-immigrant Trump administration's push for a citizenship question, helped in a potential undercount.

The Wu administration also pointed to the reclassification of race and ethnicity data.

"As a result of this Census coding, 76 percent of Hispanics in Boston chose (or were as signed) the ``some other"race" category, either by itself or in addition to other racial categories,

up from 45 percent of Hispanics in 2010," the administration said in a release. "Additionally, respondents listing Brazilian or Cape Verdean origin were reassigned by the US Census Bureau to the "some other race" and respondents that stated a Middle Eastern or North African origin were assigned to the White category respectively."

The late Mayor Thomas Menino repeatedly challenged census population estimates. In 2009. the fourth year in a row he did so, Menino said Boston was undercounted by 21,000 people. It came after the Census bureau revised the 2008 estimate to 609,023, putting the city over the 600,000 mark for the first time since the 1970s.

At JFK Library, Biden posits 'end of cancer as we know it'

cancer is something we can do together. And that's why I'm here today."

Since President Richard Nixon signed the National Cancer Act in 1972, scientists have discovered that cancer isn't a single disease, but 200 different types caused by genetic mutations. New Medicine, therapies, and early detection measures followed, according to Biden. In the last 25 years, the death rate has fallen more than 25 percent, but cancer remains the second largest cause of death in America, behind heart disease.

Over the next 25 years, Biden hopes, the "Cancer Moonshot" initiative will cut the current death rate in half and turn cancer into a chronic disease that can be managed.

Scientists, he pointed out, are exploring whether the same technology that offered up Covid vaccines can be used to stop cancer cells. But, he added: The battle against childhood cancers lacks a strategy, and there isn't enough data-sharing happening. "We know we can change the trajectory," he said.

Biden plans to use his presidential authority to "supercharge" the "Cancer Moonshot" initiative, he said, breaking logjams and speeding breakthroughs with the help of his "cancer cabinet," which was launched seven months ago.

and gene therapy precisely to the right tissues," the president said. "Imagine simple blood tests during an annual physical that could detect cancer early when the chances of a cure are best. Imagine getting a simple shot instead of grueling chemo or getting a pill from a local pharmacy instead of invasive treatments and long hospital stays."

Biden used the occasion of his visit to Dorchester to announce the appointment of Dr. Renee Wegrzyn as the first director of a new federal entity called Advanced Research Project Agency for Health (ARPA-HA) that will focus on biomedical innovation. Wegrzyn, the vice president of business development at South Boston-based biotech Ginkgo Bioworks, joined Biden at the library for the announcement.

The agency has received \$1 billion in federal funding to get up and running. "ARPA-H will have the singular purpose to drive breakthroughs to prevent, detect, and treat diseases including cancer, Alzheimer's, diabetes, and others, and enable us to live healthier lives," Biden said.

A competition is underway

for hosting the site of the new agency and receive the acclaim and federal funding that will come with it. Massachusetts is one of several states aiming to become its headquarters. The Bay State is in a strong position to get it, due to its extensive biomedical institutions and higher education sector.

According to the Mass. Biotech Council, an industry trade group, 106,704 biotech workers are employed here, with wages reaching an annual average of \$201,549. By the end of 2025, the industry could see the addition of between 26

million and 59 million square feet of Massachusetts real

A good chunk of that land could end up in Dorchester. The sprawling project known as "Dorchester Bay City" seeks to add life science, commercial and residential space on the former site of the Bayside Exposition Center on the Columbia Point peninsula, just down the street from the presidential library where Biden gave his speech.



(Continued from page 1) pleased with it because I was paralyzed and didn't know what was going on. I was really sad and depressed. I just wanted to know why I didn't die. I wanted to die, but I didn't. So, I said, 'Okay, I'm alive then. Fine."

That new attitude led her to a poetry group and eventually to a specialized watercolor class that greatly lifted her spirits. After completing her first painting, "Rhap-sody in Blue" – which is one of the works on $display\ this\ week-she$ said she was ready to face life again. "I did it and I was proud of it," she said. "I was proud of myself for making noise that I wanted to paint, and I wanted to do things everyone else can do. I

wanted to live. It was the first time I had wanted to live, honestly, since I had gotten sick."

Fournier said she was married and at age 26 working as a guidance counselor at a Greater Boston area high school. She had friends from high school and college and had her life planned out in a very specific way—similar to how she was helping her students plan out their lives. Then

one morning when she was getting ready for work, she was troubled by a cough and cold.

She tried to swallow a pill for the cough, but she couldn't. Then she couldn't swallow water, and her arms went numb. Her husband took her to the hospital and that same day she received a diagnosis of Guillain-Barre Syndrome - a disease where the body attacks its own nervous structure. It was so pronounced that day that she slipped into the coma while at the

"The next thing I remember is I woke up one day and couldn't think," she said. "My nurse was reading Harry Potter to me. I had been in a coma for about three months,

but I didn't know that. I felt like I didn't want to be there anymore, and the nurse saw me wake up and asked if I could hear her. I shook my head [yes]."

What doctors believed would be a one-year recovery period ended up being a life-changing event when the disease attacked her optic nerve, rendering her blind, and then left her paralyzed in a wheelchair. She had nowhere to go but to her parents' home, where she went through a divorce. Then came 2020 and the pandemic and she contracted Covid-19, which put her back in the hospital for a month. It was hard to find anywhere that would admit her on her discharge, given the needs she had.

"I was married and had my life all mapped out and then life happened," she said. I didn't know how unfair life could be until I got sick."

After a brief stay at a facility in Natick that she "hated," Fournier moved to the Boston Home. The change in venue to the Boston Home marked a significant turn in the road for her. Slowly, she began to hear comforting sounds. People would say, "Hi Beth," as they passed by her room, and she got a good feeling from the other residents. She began to feel at ease and joined the poetry and writing group. That's when she started asking Activities Director Kerry Donahue and Watercolor Teacher Lisa Spacco-Pearlstein if she could paint. They weren't sure if it would work, given her blindness and paralysis, but they set their minds to trying.


"She expressed an interest after the art show the first year she was here," said Donahue. "We never made any promises, but said we'd see what happens and things just fell into place. It was a great blessing... The show is the highlight of the year. Residents work hard on the show, but they also come down each week because it's so empowering to paint and find a sense of identity."

An intern at the Boston Home, Maddy Hoy, agreed to work with Fournier on her painting dream, and they were able to work out a system whereby Beth describes the colors she wants and the shape and movement, and Hoy assists in executing the painting.

"She conjures in her mind exactly what colors she wants, describing them as 'luna moth green' or 'wisteria purple' and then she expresses the shape or movement these distinct colors take on," said Hoy. "While Beth is always the one holding the brush, it's an honor to work alongside her to bring her artistic visions to life and let others see what she sees."

Nowadays, Fournier takes her morning coffee with friends as they talk about the news of the day. She paints and writes poetry, and even enjoys a cocktail on occasion. She said she wanted everyone outside of the Boston Home to know that residents there are happy, having fun, and enjoying life.

"People see you in a wheelchair and don't think you can have fun or live life," she said. "I thought that way, too, before I got sick...I don't want anyone feeling sorry for me. I don't want pity. I'm a person and I'm happy and I can be happy. All of us here are happy."

Holmes rolls to re-nomination in 6th Suffolk district

State Rep. Russell Holmes was re-nominated on Sept. 6 as he dominated his Democratic challenger Haris Hassan Hardaway, winning 75 percent of the vote in the Sixth Suffolk district.

A six-term incumbent, Holmes was the heavy favorite in the primary election. He picked up 4,284 in winning all 20 precincts that constitute the House district, which includes sections of Dorchester, Mattapan, Roslindale, and Hyde Park.

He told the Reporter that the challenge from Hardaway "made me have to work a muscle I haven't worked. Those muscles get flimsy when you don't use them. Who knew we could raise \$90,000 in four months? I didn't know that, but that's what we did. I thank Haris (Hardaway) for putting his name on the ballot. I'm better and the district is better because of it."






